Hi Felix and Chris:

As mentioned earlier in the week, please find attached the draft CBN re the rate mitigation legislation for the TBS' review (password same as previous materials). This has been prepared with no materials and should be reviewed closely. I have left comments in the margin where I am looking for specific review or confirmation of particular details. I am interested in ensuring alignment in how we are characterizing the proposal and its risks.

The note is a bit on the longer side at the moment, so suggestions to economize without losing key pieces would also be helpful.

The note is undergoing concurrent review with Energy and my management now. My ADM will likely pass this along to Cindy and Karen for concurrent review given the time crunch, but please feel to pass along as well.
