Just got off the phone with Usman, who is the Director for Conservation and Energy Efficiency at MOE.

He only had a few minutes for us, but would be happy to reconvene in a day or two. He confirmed that the current proposal is highly related to something that's been around for a little while – Bharat is going to flip an MOE BN from 2013 – so far we haven't been able to find out whether anyone in OPCD gave advice on the basis of what's in the BN, but maybe Nadine knows

They have already discussed with IESO – IESO did not give them any view, even a preliminary one, but rather flipped it to their external auditor – they are waiting to hear back from the external auditor, and will be getting in touch with energy as soon as they do
