Hi Steve,

We would like to have a call with you this morning to discuss the implications of the alternative option that was discussed yesterday and what OPG's response so far has been. I relayed to Ken, Mike and others the fact that s. 11.01 of the Trust Indenture provides for amendments to be made without consent of specified creditors and that this is one of the reasons why OPG's proposal to put Province in the category of specified creditor alone would not result in the Province getting notice of all amendments from the Indenture Trustee. I think it would be helpful to have a discussion to go over all of the related issues.

Perhaps about 11 would be a good time – would that work for you?

Also, we are reviewing the revised versions of the agreements and as relayed last evening I have questions about the new wording under limited guarantee among other points so not sure when we will review that as well.
