Great summary of the issues!

Here is my two cents:

Pg 12, 3rd bullet – 2021 (= 4 years) and 26 years instead of 25 years

Pg 18, 2nd bullet – meet the definition of (financial) asset and (financial) liability

Pg 18, 4th bullet – I agree with “being more transparent” – not sure that is sufficient – as mentioned in your bullet above it also meets the definitions of asset and liability

Pg 32 – Should it include a conclusion for the market accounts?

You can share with PSAB/AcSB the KPMG draft report dated May 16, 2017 and the rebuttal document issued to the AG on July 25, 2017 against indemnity letters from the IESO and CPA Canada.

I have not contacted Deloitte to obtain their authorization for the distribution of their opinion. We can discuss.
