Hi Heather,

In the attached please find the table that we received from your team. So far, we

have reviewed the TP agreement between MOECC (on behalf of GreenOn) and OCE. It is our understanding that the same TP agreement template has been used to establish the relationship between GreenOn and other third party recipients.

Based on our discussion, I will be working with your team on:

- Better understanding the program design for OCE / other recipients, primarily around the funding requirements.
- Any other documents that would outline the operationalization of the TPAs
- Letter from GreenOn to OCE / other third party recipients, clarifying the ongoing eligibility criteria established under the TPA – supporting A4.2(b) clause in the agreement
- Information on which other agreements have been signed by March 31 between GreenOn and third party recipient. Currently, we are only aware of one - OCE.
