Nothing major, but they could improve upon the language related to PSAS. For example, in a couple of spots, the Report says that if the 'creation of the regulatory asset/investment asset does not meet with public sector accounting standards'. The reference to 'meet' is a bit oddly worded. 'consistent with' PSAS, or 'compliant' with PSAS would likely be better wording. In terms of the impact of a difference in opinion on accounting treatment, they could also refer to the Province's 'reported deficit' as opposed to 'deficit', but these are relatively minor comments. n
