I reviewed the note ... no substantial comments. They reference the regulations as fulfilling "addressing accounting" requirements. I reviewed the reg documents you provided earlier as well -- the context relates to the reg amendments that allow the IESO and the FE to recover financing costs from consumers. The ability to do this is appropriate that allows for the application of rate-regulated accounting for the transaction. I am just flagging this descriptive language, but in the proper context, shouldn't be problematic.

Energy is tracking a last minute set of reg amendments in support of the OFHP implementation to LRC Nov 20th. They had originally thought the regs could wait until Dec 11th but we are told that the credit rating agencies have pushed back and said they need to be in place prior to them completing their analysis.
