FYI, regarding the addition of the reporting requirement in 2.01(c) of the Process Agreement (re waivers, etc. – previously in 2.09 of the Protection Agreement), OPG asked that we change it from 10BD advance notice to promptly after implementation. They are concerned with the accounting/control implications as currently written. I said that I would pass this concern on to you with my recommendation that we can live with it (based on the context of our 'after the fact review approach' generally). John was happy with that but asked if he could tell his Board that the Province would be okay with that change. I told him he could say that he spoke to external counsel for the Province who understood the point and thought that it should probably be okay. If you want to talk about the point with me, I'm happy to discuss. Hope that all makes sense. Steve
