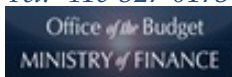

Thanks so much for plowing through that Cindy much appreciated.

My gut tells me that variance is much smaller than what we've actually seen over the years. I'm worried if we put that number in there that people will conclude that there is a low probability of any significant variance in the numbers we are showing.....the sheets I sent you suggest that the forecasts, particularly on a multi-year basis, can change by the hundreds of millions of dollars.

For now we'll add a line that says these will be subject to variability.....until we have a chance to look at it more closely. Would you agree that this analysis may cause some to think there is little chance of a variance?

I'm still not 100% sure this is what you are looking for, but the attached is a comparison of the expense in the budget and the actual expense for the Teachers' plan for the last 5 years – excluding 2015-16 (because budget was based on province's interpretation and actual on AG's).

The analysis shows that the average difference between the budget and actual was \$35 million or 5%.
