Hi Malle, we would like the next circulation of both agreements to be in final form (subject to the Province's sign off), so we are working on getting the drafting right and want to make sure that what we send you reflects both Torys' and Oslers' collective view. We expect to be in a position to send you the revised drafts tomorrow (by mid-day or earlier if possible). The good news is that I think we settled all of the open business points at our last meeting so I am hopeful that the rest is just getting the drafting right. And while we need to finalize the drafts soon, I think you should have time to digest what we send across and then perhaps we can schedule a lawyers call early next week to finalize (Monday or Tuesday, whenever you are ready to discuss the revised drafts with us).
