Hi Gadi, Ron,

The OAG has provided hard copies of Chapter 2 of her report, with recommendations that will require our attention. Recommendation #3 reiterates the recommendations from the OFHP special report (I expect Energy will take the lead with our review) as well as Recommendation #7 which is an updated version of her previous recommendation for the Province to develop a long-term debt reduction strategy.

Hi everyone,

We should aim to have a draft consolidated response approved at the ADM level by EOD tomorrow, in advance of a potential joint deputy briefing on Tuesday (TBC).
