Bonnie and Bill,

As discussed on the call on Monday, attached are the documents related to the decision to use \$8.6 of the \$13.1 billion surplus based on the funding valuation to increase the conditional inflation protection from 70% to 90%. The impact to the Province is to reduce the future payments that would

otherwise be made to the plan re: the “share the pain” payments.

As noted on Monday as well, this announcement will be made publicly tomorrow, so please treat as highly confidential at this point in time.
