Realized I never got back to you on this. Sorry about that.

Yes, the tax credits remain in place.

Yes, on the ICI expansion HOWEVER, for the 500 kw - 1 MW segment, it is restricted to only manufacturing facilities. Above 1MW you can be any type of facility. More info in the attachment I've sent you.

And yes on helping tenants. That is something that they will work on with Housing over the next few months.

I'm reading that the Ontario Energy and Property Tax Credit remains in place. What about the Northern Ontario Energy Credit. Still staying as well?

Also, in some reading, originally when the ICI program was introduced - that was 2010 and it was for consumers over 5MW - then we lowered to 3, then 1 and now 500 kw., right? Am I understanding that correctly?

So if a business uses over 500 kw usage in a month they can apply and will mostly likely qualify?

Also, on the call they mentioned that discussions are taking place with Ministry of Housing to see if there's any ways tenants in buildings where hydro is included in their rent, can benefit somehow through possible changes in the residential tenancies act? That's correct?
