Could we please be provided with a note on the Ontario Electricity Support Program, that includes information on the reapplication process and any numbers that help to explain the following:

- How many OESP participants will see their eligibility expire each month (starting April 1, 2018) for the next six months?
- How many approved OESP applicants are benefiting from the program currently, compared to numbers from the past six months?

Could we also see how the OEB is reaching out to those with expiring benefits? Would it be possible to use those extra intake FTEs that came on last year for outreach to those that need to be alerted to the fact their benefits have expired or will be expiring in short order?
