Just had a good chat with Alain. Club Powers has not heard back from the OEB since their last correspondence in October so we agreed the next step would be for me to follow up with senior staff at the board to determine the status of the file. I'll report back to Alain once I hear from the OEB where it is at.

I also explained that there isn't really anything that you can do to intervene, and that we would have to work through this matter with the board. He was very understanding.

And I noted that, despite being under contract with Planet Energy, Club Powers is still receiving the benefits of the Fair Hydro Plan (over \$500 of savings on their last bill), and he was appreciative of that.
