Eligibility for the FNDC is not based on RPP class like the GA reduction is. It's just based on occupying a residential premises on or within a FN reserve.

So would just stick with "all on-reserve residential consumers are eligible". If the occupant happens to conduct business out of their home, it does not change the definition of it as a residence.

Adding Matt for thoughts on this home business question ... I believe it would be the first time we would be saying either the small business/RPP part and considering its a live discussion, I hesitate to add additional context to that answer without ministry fact check.

What happens if a person runs a business from their home? Do they currently still have to pay delivery charges?

First Nation on-reserve residential customers that are currently registered with their Local Distribution Company for the HST exemption will be automatically eligible and enrolled to receive the First Nation Delivery Credit.

First Nations on-reserve residential customers that are not currently registered with their Local Distribution Company and who receive the HST exemption are encouraged to register as soon as possible.

This doesn't answer the question ... assuming that any RPP customer is eligible. Please check with Ministry. Thinking something like:

Any eligible Regulated Price Plan (RPP) customer, defined as any connected customer using up to 500 kilowatts per month, can qualify for the First Nations Delivery Credit.

Is that something the Ministry of Energy is willing to add on to the Fair Hydro Act?

Through the Fair Hydro Plan, Ontario has made several changes to improve the affordability of First Nation customers living on reserve.

First - Ontario has made changes to the Rural or Remote Electricity Rate Protection (RRRP) program to lower delivery charges for about 800,000 rural and remote consumers who currently face some of the highest rates.

~~The Delivery charge on consumer bills includes the cost of delivering electricity from generating stations across the Province to homes and businesses via the high voltage (transmission) and low voltage (distribution) electricity systems and also includes the cost of distribution system losses.~~

The cost of distributing power to lower-density rural and remote areas is much higher

than for urban and higher density areas.

To help offset the higher costs to distribute electricity to Ontario residents who live in rural or remote locations, eligible customers receive a credit off their bills under the Rural or Remote Rate Protection (RRRP) framework.

Second - the Ontario's Fair Hydro Plan eliminates the delivery charge for all on-reserve First Nations residential consumers, resulting in an average savings of \$85 per month.

The First Nations Delivery Credit helps address some of the unique challenges that on-reserve First Nations customers face, and to recognize First Nations' contribution to the provincial electricity system.

The proposal to remove delivery charges from band-owned buildings **has been raised by First Nations leadership** ~~was raised by Chief Hill at a Nov. 2, 2017 at a ministry-Chiefs' Committee on Energy meeting.~~ The ministry agreed to work with the **Chief's Committee on Energy** to further consider this idea.

Third – The Fair Hydro Plan increased the Ontario Electricity Support Program by 50 per cent, meaning that single, low-income consumers who receive the lowest credit amount would get an increase from \$30 to \$45 per month (\$540 per year, an increase of \$180), and the lowest credit for the enhanced scale would increase from \$45 to \$68 (\$816 per year, an increase of \$276). Ontario is exploring automatic qualification for customers who are enrolled in other provincial low-income social programs.

We recognize the importance of electricity prices for business. Maintaining competitiveness with respect to energy costs is a top government priority.

Was it ever discussed to remove the charges completely from all residents on Six Nations?

In June 2016, the Minister of Energy asked the Ontario Energy Board to examine and provide advice on options for rate assistance for on-reserve First Nations electricity consumers. **As Part of this work, the Board undertook outreach and engagement with First Nations communities to ensure that an understanding of the unique electricity issues facing all reserve community members was examined.**

Following the recommendation from the **Board**, Ontario, as part of Ontario's Fair Hydro Plan, made a decision to introduce the First Nation Delivery Credit to benefit all on-reserve First Nations residential customers.

We are also removing the monthly service charge for customers of licensed distributors that charge a bundled rate. The **Board** estimates this will provide residential customers an average monthly benefit of \$85 (or \$1,020 per year)

This automatically qualifies on-reserve First Nations residential customers — about 21,500 in total.

What happens if a person runs a business from their home? Do they currently still have to pay delivery charges?

First Nation on-reserve residential customers that are currently registered with their Local Distribution Company for the HST exemption will be automatically eligible and enrolled to receive the First Nation Delivery Credit.

Under s.35 of the *Ontario Energy Board Act, 1998* the Minister of Energy requested that the Ontario Energy Board (OEB) investigate appropriate rate assistance options for on-reserve First Nation electricity consumers.

The OEB worked with the Chiefs of Ontario to engage with First Nations throughout the fall of 2016 to gather input to develop recommendations for options to address the high cost of electricity.

On December 29, 2016, the OEB submitted its report on First Nations rate assistance options to the ministry identifying the elimination of the delivery charge for on-reserve

residential customers. The Ministry of Energy then collaborated with the Chiefs Committee on Energy to develop an approach that could provide relief from the high cost of electricity to First Nations customers in the most expedited manner possible.

On March 2, 2016 Premier Wynne announced Ontario's Fair Hydro Plan which included the elimination of the delivery charge for on-reserve First Nation residential customers through the First Nations Delivery Credit that was implemented on July 1, 2016.
