Good morning sir,

I am writing to you today to inquire about my family's hydro bill and to understand the reasoning why we are not currently benefiting from Premier Wynne's Ontario Fair Hydro Plan.

To help us with our monthly budgeting, as I am sure many others do, we participate in Toronto Hydro's equal billing plan and we do receive an 8 % credit for the PST. What we are not receiving is the additional 17% (approximate) reduction as of July 1, of this year.

When speaking with Toronto Hydro this morning they confirmed to me that those of us on an equal billing plan do not immediately benefit from the Premier's promise to reduce our electricity cost. Our family must wait until March of 2018 when our new monthly equal billing amount is recalculated. Toronto Hydro went on to mention that had we paid our monthly bills outside of the equal billing plan, we would most certainly see immediate relief! To say I am completely perplexed and to be honest, shocked as to why there is a division on who benefits and who does not, is an understatement.

Quite honestly Mr. Milczyn, I am very confident that omitting some residents from the immediate benefit that commenced July 1 is certainly not in the best interest of the Premier's intent, in particularly with the provincial election less that 6 months away.

I am asking you to look into this situation and help me to understand the rationale.
