Coming out of Minister Thibeault's presentation this afternoon about the Fair Hydro Act, 2017 we have agreed to the following briefings:

1. MPP Han Dong = Renewable Energy Policy. Distributed Generation. Q: Will DER help or hurt OFHP math?
2. Minister Damerla = OFHP "math". Q. What will price of electricity be in 2022, when the 4-year reg is lifted? What are all the factors and when / how will we know? LTEP but also she would benefit from a session with DoP / Tim C. (ESP).
3. MPP Grant Crack = Communications Question. Q. We should have an on-line bill calculator? What will be bill-design for RRRP customers, etc?
