Ontario's Fair Hydro Plan

On March 2, 2017, the Province announced Ontario's Fair Hydro Plan (the Plan) aimed at reducing electricity bills by 25 per cent on average for all residential consumers in the province. As part of the Plan, the Province has proposed refinancing a portion of ~~total electricity system~~ Global Adjustment costs over a longer time period for residential consumers. According to the Plan, the Province intends to introduce legislation that would, if passed, enable the IESO and OPG to work together to undertake this financing. The Global Adjustment ~~portion of the total price of electricity~~ in the province is administered by the IESO. The Global Adjustment includes the difference between Ontario's electricity market clearing price used to dispatch generation and the prices paid to contracted and regulated generators in the province, and the cost of conservation and demand management programs. Virtually all generators in Ontario have bilateral contracts with the IESO that provide for payments that are different from the market clearing price of electricity, while the prices for all of OPG's nuclear and most of its hydroelectric generation are set by the OEB. OPG intends to work with the Province and the IESO as part of the refinancing proposal.
