Letting you know that we've received a Notice of Mediation for contentious access request TBS 2018-007 related to Fair Hydro documents received by the AG. This request was also received by Finance and Energy, which have also received notices of mediation for their requests.

We do not know the reasons for the mediation request.

Our interim decision, released February 21, 2018, was for partial access. We also notified the requester of the estimated fees and advised them that a 50% deposit of the estimated fees was required to continue processing the request. A redacted copy of the interim decision is attached for your reference.

Our office is working to provide the IPC with the requested documentation (original request and interim decision); no further action is required of TBS at this time.
