Couple quick comments to flag from OPCD below and also reflected in the attached in red:

- Deleting last sentence on slide 9 (same point is also on slide 8 and wouldn't be TBS to speak to)
- the last bullet on slide 8 says "if rate regulated" – it leaves it open as to whether or not the IESO is; taken from the AG response document, suggest weaving in the following definitive statement:
The IESO is rate-regulated by the OEB in accordance with the Electricity Act, 1998 (Electricity Act) and the Ontario Energy Board Act (OEBA).
- Removed the ampersand in "E&Y" on slide 9
