Re: Freedom of Information Access Request No. 2017-033

I am writing to you regarding your request to the Treasury Board Secretariat under the *Freedom of Information and Protection of Privacy Act* (FIPPA) for access to the following records:

1. Copies of all emails, memos and/or briefing materials responsive to the request(s) made by the Auditor-General of Ontario and/or her office, in connection to her special report on the government's Fair Hydro Plan, and that were released to the Auditor-General; and
2. Copies of all emails, memos and/or briefing materials responsive to the request(s) made by the Auditor-General of Ontario and/or her office, in connection to her special report on the government's Fair Hydro Plan, and that have not been released to the Auditor-General.
3. A summary of outside consultant and/or legal fees paid and/or payable by the government in relation to the preparation and/or roll-out of the government's Fair Hydro Plan.

Our preliminary search indicates that approximately 10,000 records totaling approximately 105,000 pages will require review to respond to your request.

Interim Decision

After a review of a sample of the responsive records, an interim decision of partial access has been made. At this time we believe that the following exemptions apply to portions of the records:

Section 12 – Cabinet Records

Records which could reveal the substance of deliberations of Cabinet and/or its committees

Section 13 – Advice to Government

Records which contain advice and recommendations to government

Section 18 – Economic & Other Interests

Records which if released could reasonably be expected to prejudice the economic, financial, competitive or negotiating interest of the province

Section 19 – Solicitor-Client Privilege

Records protected by solicitor-client privilege

Please note that the official responsible for making the access decision on your request is Melanie Fraser, Chief Administrative Officer and Assistant Deputy Minister of the Corporate Services Division, Treasury Board Secretariat
