Attached please find an updated version of the communications approach/options further to Mike's email below.

As you'll see, I updated Scenario 1 to give you a sense of what we're looking for under each of the other scenarios. Basically, grouping everything related to that particular scenario in one place – primary tactics, risks and considerations, and narrative.

You'll notice that the Considerations category is gone because I moved the bullets around. I left the Key Messages for reference as you'll still have to draft a narrative for the remaining scenarios.

We thought it would be helpful to add a Timeline to capture the immediate deadlines and letters. That's under the objectives. (Not sure if the AG has three days to respond to our letter?)
