Good morning,
Please see the release below and the report attached.

It provides an overview of the office's activities, role, and legislation governing it. On access to information, the FAO notes that the "order-in-council, combined with ministries and public entities' improved understanding of their duty to provide the FAO with information, has improved the FAO's access to information necessary for the performance of the FAO's duties."

However, the FAO also states later in the report that he "is concerned that some ministries and public entities do not always provide information in the "timely manner" required by subsection 12(1) of the FAO Act."

In 2016-17, the FAO made 29 information requests of ministries and public entities. As of July 2017, all but one of these requests have been fulfilled.
