You will see the letter reference FOI requests where the response was "no records exist".

I check with Jamie Forrest on any FHP requests with such a response. There was a CO request related to consultant costs, and the response was that no records exist. However, the letter went on to say that this is because the Cabinet Office did not retain any consultants for work on the FHP. The letter also went further to say that EY and KPMG were on retainer by OPG and IESO. So the letter was more than just no records exist.

The requester (media) tweeted that they were told "no records exist", but of course did not go on to reveal the helpful parts of the letter.

We should decide whether you want to address this in your response back to Mr. Brown's office, since if they were referencing only a media tweet, they did not get the full story. I think we should include this in your letter - particularly if Mr. Brown's office posts it or tweets it (which I expect they will). It is a good chance to get the entire context out there.
