Hi,

I have just reviewed (was on the computer, timely or bad luck perhaps?!) and have embedded my comments in energy's tracked changes of the CBN. The changes to the minute look good and think we can probably accept them.

On the note, the only main concern I have is that they are implying we are taking action for class B – they say “support for class B (e.g., ending DRC, lowering ICI threshold, etc)”. They did not include anything in the minute though on class B. I worry that we can't just list “e.g.,” in the note, we are either taking action through this submission on class B or we are reporting back on options to support class B which then could be “e.g.”

When you open the tracked changes version you may receive a shock but it actually isn't that bad as they seemed to have deleted many parts of the note and then just rewritten them so in reality they haven't changed as much as it may look like.

My comments on their changes are embedded in version I have attached here. I think the outstanding piece is class B now. As well, they have not changed the tenants part of the minute, which is to report back. I think that is the best place to land for now if we can as having seen MOH's slides (or MHO, never know) not sure we know what action to take, just that we want to look at what action may be best.
