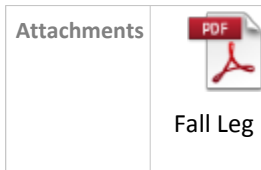

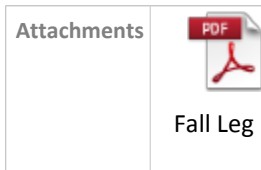

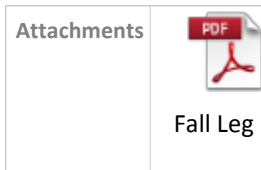

Hi policy teams,

Last week, PO requested some information on unproclaimed Acts from 2013. Since the resulting information is something that may be of interest to policy areas, we wanted to share.

Information on unproclaimed provisions can searched/downloaded/found on eLaws website at:

Attached are two products:

1. Summary of Bills from 2013 to present
 - Grey highlight indicates one or more provisions/sections within Bill are still awaiting proclamation
 - Yellow highlights indicates proclamation comments, such as most of the Bill's outstanding unproclaimed provisions are waiting for proclamation, or where a full schedule is awaiting proclamation, or Bills in the House which will require proclamation
2. Provided by OLC from the above website, an excel spreadsheet on outstanding procs which includes the parent statute that is impacted and the ministry responsible
 - Can be filtered, as appropriate (note that some areas are "shared", meaning more than one ministry is responsible)

There are a lot of proclamations tracking over the next two LRCs; however, if questions come up, this may be a useful tool.

Hi Rob,

Please find attached a summary of Government Bills introduced from February 2013 to present. In relation to the outstanding proclamations, I used the online tool ([legislative tables](#)) to go through each bill and summarized as follows:

- Grey highlight indicates one or more provisions/sections within Bill are still awaiting proclamation
- Yellow highlights indicates proclamation comments, such as most of the Bill's outstanding unproclaimed provisions are waiting for proclamation, or where a full schedule is awaiting proclamation

In addition, I'm sending an excel spreadsheet, which can filter only the unproclaimed provisions from 2013 onward (filter as showing only "blanks" in column C). This would be equivalent to the information that would be populated using the online search, and is helpful as it identifies the parent statute that is impacted by the Bill's provisions. (Full disclosure, I didn't do a line by line review of this, as I used the online tables when populating my summary)

I hope this is helpful as a snapshot of elements still requiring proclamation. OLC is undertaking some work on this, but it would be helpful to determine more specific interests and we can go from there.

I will drop off a hard copy of these documents later this afternoon. If you have any questions, please let me know.
