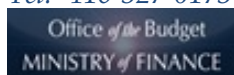

Hey everyone

First of all, I understand our weekly meeting tomorrow is being pushed off to another time because us over here in MOF and TBS have a joint DM briefing to help prep for upcoming meetings next week.

Second, I still think its important that we find time to connect tomorrow if possible, or early on Monday, to start sorting through the list of emerging policy items with costs, and the overarching approach to better aligning fiscal and policy considerations as we move into the fall and towards Document. I'd also like to make sure we can show Scott and Helen that we are responding to Steven's email request yesterday for us to work on a process and list that is fully integrated across the "triangle" of central agencies.

In that vein, please find attached:

- A proposed agenda for us to use as a guide for our discussions together (I'd also suggest we rename our weekly meetings to "weekly fiscal/policy alignment" but that's just window dressing)
- A placemat that begins to map out ways in which we can better align the fiscal and policy pieces of the decision-making processes which my Strategic Policy team has put together using the email Shamira forwarded from Tamara Gilbert, and building on discussions our directors have been having over the past week or so on this topic.

We are also in the process of finalizing our emerging policy tracker which I will walk copies of into the meeting whenever it happens (tomorrow or Monday). This would also respond to Steven's request that we develop a shared list and understanding of all the moving parts in the system right now.

Hope I can get your support for a discussion such as this, and to work to better integrate the various moving files and overarching processes we support as central agencies.
