- * **(P.6) Hydro:** Details of the province's Fair Hydro Plan are in the budget, but the implementation of the plan will not be included in the Budget Bill, when it is introduced.
- * **A spokesperson for the Minister of Finance said a separate piece of legislation mandating the 17 per cent reduction in residential hydro bills will be introduced "soon."**
