Hey Martha,

See our first draft of the PD&G deck from David and Karen. Few notes here:

- Energy items on slide 8 have not been filled out – Tim is waiting to hear confirmation from ENE on the measures of success and actions over the next year before he plugs them in
- Rebecca is still waiting for confirmation from MOL on the measures of success and risks, she has added them in for now
- David has reviewed from his team and I believe Karen will review in parallel with you

Hi John,

Thanks for following up, just looping in 4th floor folks on the new proposed approach. Given the busy Cabinet preparation schedule this week, we are proposing to revise the original request and just have policy teams make the following updates by Friday, August 25 2017, includin:

1. Update PD&G deck to capture appropriate info on risks and status – see updated template attached. Note, we have pre-populated the key risks section with the latest August updates teams have been working on for review and updates.
2. Ensure the Digital Risk Tracker Pilot (Tracker) database is up to date with milestones, specifically from the September 2017 to September 2018 time period, including milestone name and description. Monday we will pull the milestones from the system to populate the appendix of the PDG deck before circulating it one more time to teams for validation.

Next steps:

- Early the week of August 28—SIB will consolidate input on the slide deck and create an appendix using milestone description information from the September 2017-2018 that has been inputted in the system.
 - o SIB will share the revised deck with 6th and 4th floor policy teams for validation
- September 1, 2017—draft deck will support a PD&G planning meeting with ADM/ECs/DMO

Thanks for chatting! Just to bring everyone on same page, I believe our new approach for this request would be:

Hi everyone,

We're in the process of updating the Priorities Report for the September 14th PD&G meeting (mentioned in Rob Foster's email below). Martha/Shamira – just a heads up that the SIB team is going to be canvassing your advisors to populate an update to the deck Steven took to PD&G in the summer.

At a high level – will be focused on the coming year (September to September) and take a bit of a deeper dive on the delivery risks and potential for and impacts of slippage.

Lucia is also going to pull together some material that could outline the context for the leg session, in terms of what they have in the hopper already, what policy items could have leg requirements and the limited bandwidth we have for new bills.

We'll probably bring everyone all together later next week (or the week after) but SIB is going to pull an early draft together and share with folks in advance.
