Tue Oct 24	Low	NEW - Affordability Fund Launch (Hamilton) The ministry will announce the launch of the Affordability Fund, part of the Ontario Fair Hydro Plan. As part of the Ontario Fair Hydro Plan, in March 2017 the government announced the establishment of an Affordability Fund that will provide energy efficiency measures to electricity customers who do not qualify for the Save on Energy Home Assistance Program (HAP), and who are unable to undertake energy efficiency improvements without support.		Q&As (holding messaging)• The Affordability Fund is part of Ontario's Fair Hydro

				Plan. The \$100 million fund is designed to help those who don't qualify for the Save on Energy Home Assistance Program and are unable to make energy efficiency improvements to their homes to help reduce their future electricity bills. • There are approximately 50,000 households in the province that could benefit from this fund. Customers can contact their electricity distributor to find out if there are eligible. • Those who qualify for assistance could receive anywhere from \$260 to \$6000 to help with their electricity bills and improve the energy efficiency of their homes and apartments. • Ontario is lowering electricity bills by 25 per cent on average for residential customers as part of a significant system restructuring that will address long-standing policy challenges and ensure greater fairness.
