Hello Sarah,

TBS is currently processing an access request related to pensions, with the search for records conducted by the DMO and MO. The two attached records are responsive and we will be sending notice/consultation to Deloitte, Ernst & Young, and the AG for their views on disclosure. I have a couple questions for you to help facilitate this process.

First, the Deloitte record (found in Record 54) does not have any contact information and I was hoping you'd be able to provide a contact that I can send this to.

Second, the EY records (found in Record 133) will be sent to EY for their views, but also to the AG. I've discussed this with Legal, and we've noted that the records state we need to give notice to EY if we share them. I'm hoping you can provide some advice around how best to do this. Our office can include the fact that we're sharing the records with the AG in the notice to EY when we send the records for their views, or either of our offices can give them advance notice separately from the consultation.

I will need to get these consultation notices out soon in order to maintain compliance with our legislated timeline, so I would appreciate if you could let me know by end of day tomorrow.
