- FHP: see attached
- Pension Asset: She would like this to be re-positioned somewhat given the change in the note title and the timing (i.e., less about the panel details upfront and more considerate of recent commentary e.g., FAO/OAGO/political). Additionally, some of the bullets are really long and it might be worthwhile to format a bit differently to make this a bit more user friendly.
- Public Accounts: Can we add reference to the pre-election report somewhere appropriate? It's forward looking but is essentially the most recent review of the accounts. She's ok with the rest of it but thinks someone needs to take a look again once all the track changes are tidied up to ensure the structure still works (this is probably something that Comms will/could do once the content is landed).
