For starters, this is a TB/MBC submission, not a business case; you are seeking permission to establish the panel by Minister's order; approval of the terms of reference; and TB/MBC recommendation of a remuneration OIC to Cabinet.

All the material naming individuals should come out. You can talk about the type of people that are going to be appointed, but TB/MBC does not approve personnel. TB/MBC should simply note that appointments will be by Minister's letter using the regular PAS processes.
