1. \$975million with OFA, Dec 2019 (to be changed to \$475million because of Fair Hydro facility below)
2. \$150million with TD, April 2020 (formerly \$100million)
3. \$160million with OEFC, June 2020 (formerly \$95million)
4. \$120million note with OEFC, June 2020 (formerly \$90million note)
5. \$2 billion with OFA for Fair Hydro programs, Sept 2022 – draft docs are received....I can send once finalized.
