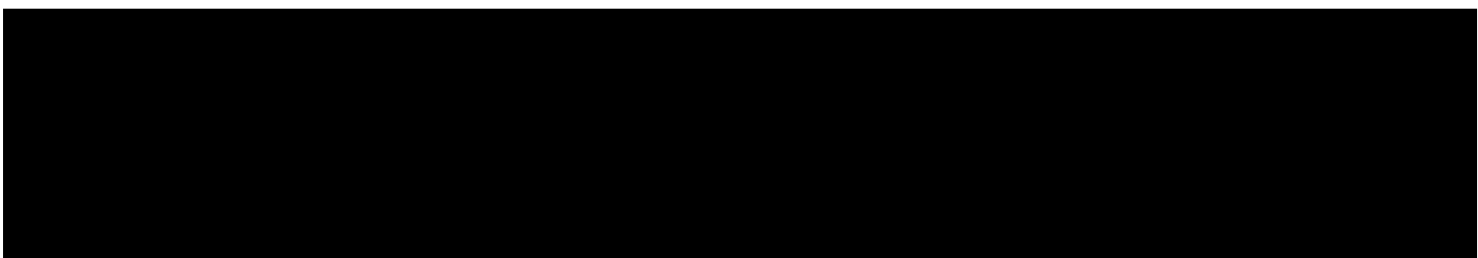

Hi Alena,

Attached is a first draft of a Fair Hydro funding commitment agreement. This form works better if what is proposed is a payment, rather than a loan. As stated in the note to draft in the document, if we pursue a loan, the IESO would need the ability to recover amounts from ratepayers in order to repay the loan.

I haven't socialized this with anyone else in the IESO but wanted to get it over to you so you could review and consider. I will be circulating it internally to various clients now as well.
