Anthony / Jeannette,

Attached is an updated Transfer Notice. Note that it does not have your account details yet.

In the email below you've identified 2 key items you require to complete the transaction mainly related to the carrying costs and I added 2 other items for the carrying cost report and signed transfer notice:

- 1) Documentation of set up of the Trust
- 2) Letter from the bank verifying the Trust bank account details.
- 3) Carrying cost report from the Trust
- 4) Signed Transfer Notice to support subordinated debt

Due to the delay with closing and finalizing documentation we are looking at ways to satisfy your requirements in some way as many of the agreements establishing the structure are inter-linked so it is difficult to just get one document.

- 1) Declaration of Trust – the challenge with this item is the trustee's signature as this document is tied to the Management Agreement that is signed by the trustee and OPG; this agreement is in turn tied to the MTSA which is signed by both the IESO and OPG as manager of the trust. We could possibly provide the Declaration of

Trust on Friday with OPG's signature and provide the trustee's signature later. What is the minimum you require to set up the carrying cost and when is the latest time to receive the information? Does it cause any problems if the document indicates that the structure is effective on the closing date?

- 2) Letter from the bank for Trust account details – the account is being set up pending finalization of documentation. What is the latest date to receive the letter? Could a
- 3) Carrying cost report – we could provide a signed report however the report arises from the MTSA which may not be effective until closing.
- 4) Another aspect is our need to provide the Transfer Notice to the Province as part of their funding of the subordinated debt. They are looking for a signed version of the Transfer Notice to complete their side of the transaction. Is there a way to get the signed Transfer Notice before closing.
