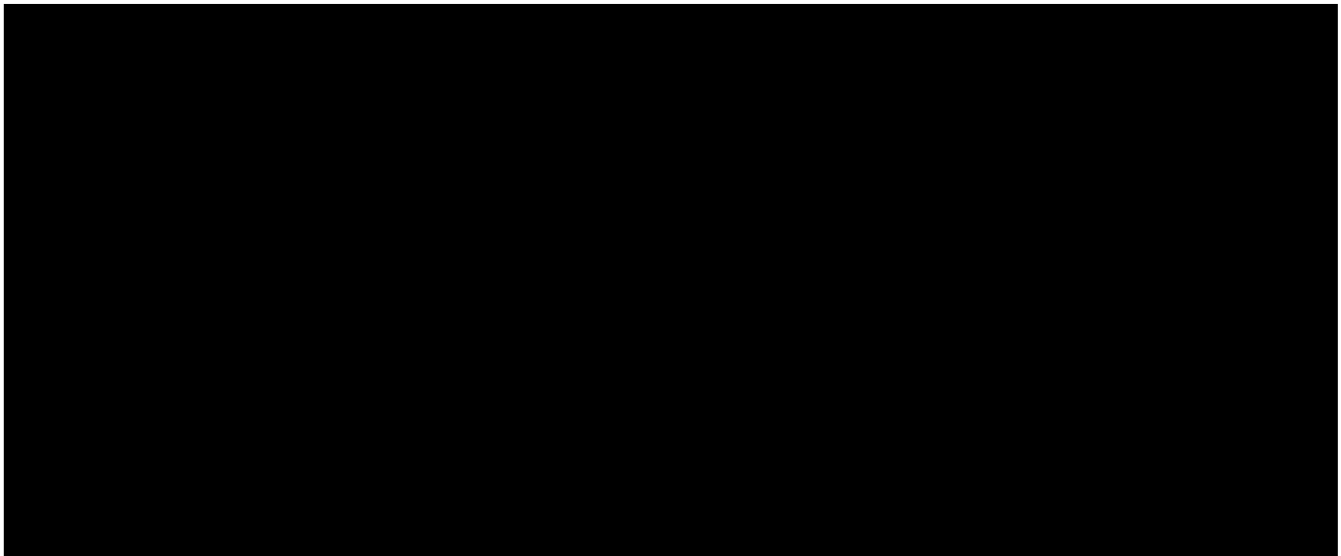

Re: Treasury Update

The following are key updates for your information.

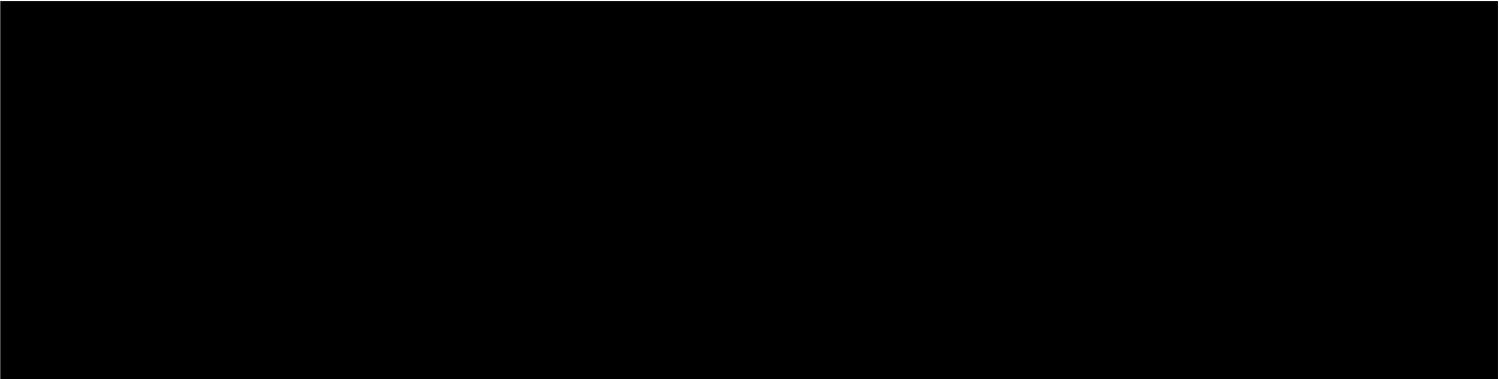


Fair Hydro:

On December 21, 2017, the IESO successfully completed and transferred \$1.179 billion fair hydro receivables to the Fair Hydro Trust and immediately paid down the corresponding OFA debt. As at December 31 2017, the IESO had less than \$1 million in OFA debt related to the fair hydro program. On February 8, 2018, the IESO offered to transfer \$332 million to Fair Hydro Trust for the months of December's and January's electricity fair hydro activity.

Debt:

As at December 31, 2017 the IESO had the following outstanding debt:

- \$1 million regarding fair hydro program – variable interest rate, Province of Ontario's cost of borrowing plus 0.25 percent per annum;
