I agree record 2 does not relate to "financial/ accounting structure of the Fair Hydro Plan", this was analysis done before the structure that turned into Fair Hydro was landed on. If Ministry insists they wish to include it, we will need to have whoever prepared it review for confidentiality concerns, and I think we could also claim s.13 advice to government exemption, although in this case it should be the government that claims it.

Record 3 does not relate to Fair Hydro at all.

Record 108 – responsive but the email from Michel Picard to Kim Marshall is advice to government (i.e. IESO in this case). We could claim section 13 if the IESO did not want this disclosed to the requester.

Record 127 are the IESO's white papers regarding accounting that was part of Fair Hydro. They are responsive. Crystal or Anushka, do you know if these were released in the other Fair Hydro FOI request, or if we made redactions or claimed exemptions?

Record 179 – this is responsive and I don't see an exemption that is applicable to this record.

I agree, it is related to rate mitigation but I do not think it is responsive to the request i.e. "financial/ accounting structure of the Fair Hydro Plan". I was at this briefing and recall that it took place before FHP was conceived. Based on a request we received from the ministry, we looked at options for reducing rates. None of those options are related to Fair Hydro.

It's your call... but I thought I would give it one more go. If this does get released I think it may need to go through Chuck's group for review too.
