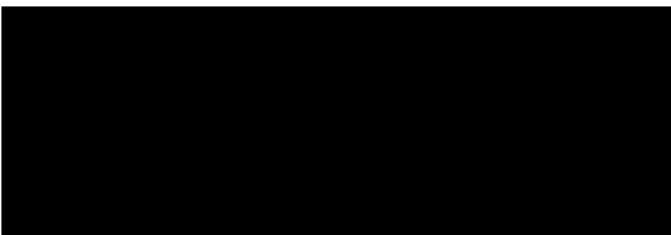
- the proposed accounting policy change to adopt regulatory accounting; and
