Week In Review



Hydro One ombudsman quietly stepping down, Toronto Hydro fees under review, and Ontario manufacturers' skepticism about new hydro plan topped this week's [energy headlines](#).

The *Toronto Star* is reporting Hydro One Ombudsman Fiona Crean quit on March 10, less than two years since taking on the job. Energy Minister Glenn Thibeault had no explanation for the secrecy of the departure, but noted that the office is now running an executive search for the right person.

A new fee Toronto Hydro has levied against individual customers for disconnecting their hydro for repairs is being reviewed by the Ontario Energy Board, according to *Global News*. According to Toronto Hydro, all ratepayers were "subsidizing" the cost for a small number of customers who accessed the customer isolation repair service each year, costing between \$1,000 and \$3,200 for each disconnection-reconnection call.

The Coalition of Concerned Manufacturers told the *Hamilton Spectator* that their members don't qualify for a 17-per-cent cut to their electricity bills, noting some businesses are too small for the Industrial Conservation Initiative or too big to qualify for the programs outlined in the Fair Hydro Plan.
