Reads very well. I would edit anything.

Bruce, you talk to the 25% bill reduction but do not include any reference to the exact deferral amount which is appropriate because we do not know the exact value/ percent. However, if questioned you should know the 25% include the 8% Ontario Rebate For Electricity Consumers and Fair Hydro Plan removes OESP and a large portion of RRRP representing together approximately another 2% off bills to go to Provincial revenues. In other words approximately 10% is not a part of the deferral.
