Sorry for the late notice but we will postpone tomorrow's meeting until next week. OPG has indicated they are now targeting to have IESO and OPG sign the Master Transfer and Servicing Agreement and related agreements the end of next week, or latest Monday (December 11) the following week. The timing for having final approved agreements has moved out because OPG is not going to the bond market in December, and therefore does not need to undertake marketing activities next week, for which they would have needed final agreements.
