Hi Michael,

The attached does not. There has been regulatory amendments to O.Reg 196/17 (invoicing requirements) regarding the on-bill display of customer-specific Ontario Fair Hydro Plan (OFHP) savings on the electricity invoices. This became effective on January 1, 2018 and requires compliance by March 31, 2018.

A suggested proposed message would be:

You have received your monthly IESO invoice inclusive of Ontario's Fair Hydro Plan. **Ontario's Fair Hydro Plan saved you "insert specified amount" on your bill.** This saving includes the 8% provincial rebate.

We can use the previous request except to comply, the message will need to include the actual dollar amount saved on each invoice.

I can call to discuss further.
