Subject: Ontario Rebate for Electricity Consumers - Invoicing Requirements

Hello members of the Ontario Fair Hydro Plan LDC Working Group,

This e-mail is to let you know that Ontario Regulation 166/17 has been filed with the register and is available on e-laws. This Regulation amends O. Reg 364/16 governing invoicing requirements for the Ontario Rebate for Electricity Consumers – the 8% rebate. The regulation amendment **repeals** the requirements to 1) include the phrase “The Ontario government is providing a rebate on your electricity costs equal to the provincial portion of HST” on your invoices, and 2) provide your paper invoices in envelopes marked with 8% rebate informational messaging.
