I think we should add something about FHP to the How is global adjustment charged to electricity consumers on the What is Global Adjustment page. How about the following wording as a last paragraph under the bulleted paragraph below:

Effective July 1, 2017, under Ontario's Fair Hydro Plan Act, a portion of the global adjustment costs related to the Government of Ontario's clean energy initiative will be allocated to future consumers of electricity, resulting in reduced electricity bills for current eligible specified consumers. For more information, see the the OEB's report on how prices are changing for these eligible customers. See also Ontario Fair Hydro Act, 2017.
