If you have concerns with the disclosure of the records, you will need to explain how the records reveals a trade secret or scientific, technical, commercial, financial or labour relations information, supplied in confidence implicitly or explicitly, where the disclosure could reasonably be expected to,

- (a) prejudice significantly the competitive position or interfere significantly with the contractual or other negotiations of the IESO;
- (b) result in similar information no longer being supplied to the IESO where it is in the public interest that similar information continue to be so supplied;

(c) result in undue loss or gain to any person, group, committee or financial institution or agency

Please provide as much detail as possible; and for ease of reference, indicate page numbers where redactions need to be applied.
