In other news, we're already working with them on the rate mitigation options. Joyce is lead on this overall, David is the main man from my shop on this. In meantime, i'll work on estimate re: update work timing which may or may not be moot, depending on the turnaround expectation, which I understand is being discussed as we type/read.
