FYI - This was quickly compiled to respond to the ministry's urgent request for data with these specific assumptions to address questions from the MO and beyond.

The heavy caveats are to make it clear the impact that the Time vs Quality compromise may cause. We determined that not responding is not an option, since we recognize the important work underway and that IESO is clearly uniquely positioned to address -- in any case we have seen the executive pressure applied even when we say yes.

Although we try to make efforts to develop the more complete analysis for the questions on the renewables, these urgent requests for "quick and dirty" calculations that result in risky & rough approximations, get in the way of the more complete answers and can result in confusion of the results even internally within the IESO as we have seen.

We will continue to manage the interface with our colleagues up the street and get the job done.

Hi Daniel and Tim,

Please find attached the additional information requested. This attached is an Estimate of Costs that includes the elimination of the LRP II and EFW procurements. There is no changes made for the new Hydro Quebec deal, ICI expansion, Proceeds Recycling, RRRP increase.

It is important to recognize that the excluded items listed and the draft nature of this LRP II and EFW case run will have implications on the information attached. IESO is of the view that this attached information should be used with caution and is a DRAFT that recognizes the exclusion and refinement that need to be made. For example, the ICI expansion will impact the GA rates provided, the Hydro Quebec deal will also likely reduce the HOEP rates, and etc.

As a result, please ensure that information used from the attachment notes the fact these are draft numbers and identify the exclusions noted above.

Hi Tim and the MOE folks,

Please find attached the Residential Monthly Bill (assuming 750 KWh/Mth) and Industrial Rates, which includes the Ministry of Energy's cost assumptions for the Proceeds Recycling, RRRP, and ICI Expansion as given below. These cost assumptions are layer on to the residential bills and industrial rates produced from a Draft Case Run of the OPO that excludes LRP II (plus expansion) and EFW procurement programs. The model run does not have the current Hydro Quebec deal included.

The AG report indicated that the residential bill increased by 23% from 2015 to 2020, as based on the 2013 LTEP. The current attached residential bill increase for the 2015 to 2020 period is 18%.
