Thanks David

We are working with the Canadian Federation of Independent Grocers on an energy study under direction from MOE. The sector is mostly caught in the middle of our programs (too large for energy consumption thresholds for small business and too small for ICI and mostly not large enough for EPP except Longos). They are also somewhat impacted by late timing of BRI launch (Ottawa specific member comment), and their members will not receive significant benefits under the Fair Hydro Plan.

We want to review with the Working Group what we are doing and why so the input can be used by the working group for potential program recommendations. We also want to advise the Group with respect to communication that would be going out to CFG members so LDC's are aware, not surprised and ready for follow-up. The initial phase of the work would be completed by the end of August, so ideally we could join on August 9th, but we are open to alternate ways of advising and getting feedback if need be. We expect to be sending communication by e-blasts to their members.
